AUTHORIZING FY 2023 SUPPLEMENTAL BUDGET NO.4 OF THE MUNICIPALITY OF MANUKAN, ZAMBOANGA DEL NORTE IN THE TOTAL AMOUNT OF EIGHT MILLION EIGHT HUNDRED TWENTY TWO THOUSAND NINE HUNDRED THIRTY EIGHT PESOS AND 12/100 (#2 8,822,938.12)

Section 1. Authorization. This Appropriation Ordinance shall authorize the expenditures in the Municipality's FY 2023 Supplemental Budget No.4. Funds needed for its implementation shall be sourced from the Unappropriated Balance in the General Fund in the amount Three Hundred Thirty Six Thousand Four Hundred Sixty Eight Pesos and 66/100 (P 336,468.66) per Appropriation Ordinance No. 2023-A008.
