RESOLUTION DECLARING IN ORDER AND APPROVED THE BARANGAY ENACTMENTS OF BARANGAYS SAN ANTONIO, PATAGAN, MATE, MESES, SERONGAN, SALUYONG, PALARANAN AND SUISAYAN, ALL OF THIS MUNICIPALITY

Referred to the Municipal Budget Officer for study and appropriate recommendation of the following barangay enactments: Appropriation Ordinance No. 02, series of 2025 of Barangay San Antonio, this municipality, realignment of the savings in Capital Outlay Expenditures- Current Appropriation in the amount of Twenty Thousand Pesos (P 20,000.00); Appropriation Ordinance No. 03, series of 2025 of Barangay San Antonio, this municipality, realignment of the savings in Capital Outlay Expenditures- Continuing Appropriation in the amount of Two Thousand Four Hundred Nine Pesos and 31/100 (P 2,409.31); Barangay Resolution No. 27, series of 2025 of Barangay San Antonio, this municipality, adopting BDC Res. Thousand Twenty Two Pesos and 53/100 (P 102,022.53); Fiscal Year 2025 Barangay Supplemental Budget No.01 of Barangay Mate, this municipality, involving an appropriation amounting to Thirty Five Thousand One Hundred Twenty Three Pesos and 31/100 (P 35,123.31); Fiscal Year 2025 Barangay Supplemental Budget No.01 of Barangay Meses, this municipality, involving an appropriation amounting to Fifteen Thousand Pesos Only (P 15,000.00); Appropriation Ordinance No. 01, series of 2025 of Barangay Meses, this municipality, realignment of the savings in maintenance and other operating expenditures in the amount of Twenty Seven Thousand Pesos (P 27,000.00); Barangay Resolution No.006, series of 2025 of Barangay Meses, this municipality, adopting BDC Res. No. 02, series of 2025, reprogramming the amount of One Hundred Fifty Six Thousand One Hundred Thirty Four Pesos and 20/100 (P 156,134.20) out of the 20% EDF Continuing Appropriation; Barangay Resolution No. 05, series of 2025 of Barangay Meses, this municipality, adopting BDRRMC Res. No. 001 and BDC Res. No. 01, prioritizing the programs/projects/activities of Barangay Disaster Risk Reduction and Management Fund (BDRRMF) Trust Liability in the amount of One Hundred Thirty Nine Thousand Six Hundred Eighty Five Pesos and 46/100 (P 139,685.46); Barangay Resolution No. 014, series of 2025 of Barangay Serongan, this municipality, reprogramming the amount of Five Hundred Eighty Seven Thousand Four Hundred Sixty Seven Pesos and 90/100 (P 587,467.90) out of 20% EDF Continuing Appropriation; Barangay Resolution No. 008, series of 2025 of Barangay Saluyong, this municipality, adopting BDRRMC Res. No. 001 and BDC Res. No. 01, prioritizing the programs/projects/activities of Barangay Disaster Risk Reduction and Management Fund (BDRRMF) Trust Liability in the amount of One Hundred Seventy Thousand Thirty Eight Pesos and 95/100 (P 170,038.95); SK Resolution No. 07, series of 2024 of Barangay Palaranan, this municipality, approving the programs/projects/activities of the 10% SK Fund for FY 2025 in the amount of Three Hundred Five Thousand Eighty Six Pesos Only (P 305,086.00); and SK Resolution No. 03, series of 2025 of Barangay Suisayan, this municipality, approving the prioritize programs/projects/activities of the 10% SK Fund for FY 2025 in the amount of Three Hundred Twenty Two Thousand Nine Hundred Ninety Six Pesos and 60/100 (P 322,996.60);

NOW THEREFORE, premises considered, and on motion of Hon. Flerida M. Agustin duly seconded by majority of the members present, It was
