A RESOLUTION REQUESTING THE MUNICIPAL MAYOR THRU THE MUNICIPAL ENGINEER TO PUT A WAITING SHED AT THE DESIGNATED BUS STOP AREA IN THE MUNICIPALITY OF MANUKAN, ZAMBOANGA DEL NORTE

WHEREAS, most Public Utility Buses and Jeepneys will not pick-up passengers at the heart of the town:

WHEREAS, said Public Utility Buses and Jeepneys will only load and unload passengers at the Designated Bus Stop Areas outside the heart of the Poblacion;

WHEREAS, said scenario has caused serious inconvenience to all passengers especially to the Persons with Disabilities (PWDs), Pregnant Women. Children and especially to all Senior Citizens;

WHEREAS, serious inconveniences encountered by the above-mentioned sector of the society has been intensified due to the absence of a passenger waiting shed where they could sit comfortably while waiting for a ride, rain or shine in going to their respective destinations;

WHEREAS, at present all passengers waiting for a Public Utility Buses and Jeepneys are just standing at the shoulder of the National Highway under the mercy of the heat of the sun when it is a sunny day and at the mercy of rain when it is during wet season which is very hazardous to the health of all sectors in the society;
