1. Subscribe to the Land Bank of the Philippines' (LBP's) internet banking facility known as "weAccess", and
2. Designate authorized signatory to enroll and designate authorized user/s in the LANDBANK weAccess.

3. amend/add/delete enrolled deposit account/s as source and/or destination account/s, access rights to the weAccess modules, authorization rules and/or any information on the original and succeeding enrollments.

RESOLVED FURTHER, that this is an addendum to the signatories of the submitted resolution for account opening;

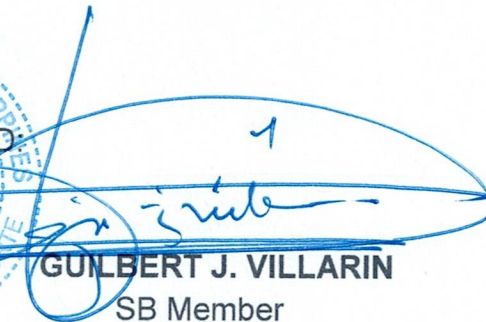
RESOLVED FINALLY, to furnish copies of this resolution to all concerned agencies for information and appropriate action.

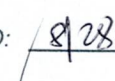
