**A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO AND
SIGN THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF TRADE
AND INDUSTRY – ZAMBOANGA DEL NORTE PROVINCIAL OFFICE, REGION IX
RELATIVE TO THE ESTABLISHMENT AND OPERATION OF NEGOSYO CENTER
IN THE MUNICIPALITY OF MANUKAN, ZAMBOANGA DEL NORTE**

WHEREAS, the Department of Trade and Industry is the primary coordinative, promotive, facilitative and regulatory arm of the Philippine Government in the area of trade, industry and investment;

WHEREAS, the Municipal Government of Manukan is the local government unit (LGU) mandated to govern and administer the municipality, vested with corporate powers to promote the general welfare, deliver basic services, and implement local development programs in accordance with the Local Government Code of 1991;

WHEREAS, the approval of Republic Act 10644: An Act Promoting Job Generation and Inclusive Growth through the Development of Micro, Small and Medium Enterprises otherwise known as the Go Negosyo Act is seen to bring government services closer to small businesses through the establishment of Negosyo Centers in all provinces, cities and municipalities;

WHEREAS, with the Go Negosyo Act, the Department of Trade and Industry (DTI) with the support of LGUs and other government agencies expect to further boost its assistance to Micro, Small and Medium Enterprises (MSMEs) to grow and flourish and intensify the promotion of entrepreneurship in the country;

WHEREAS, the Negosyo Centers would facilitate development programs as well as provide support for business conceptualizations, management, team building, marketing, human resources and many other aspects of maintaining businesses;

WHEREAS, the Negosyo Center shall provide services to MSMEs on Business Advisory/Consultancy, Business Registration Assistance, Business Information and Advocacy, Product Development, Trade and Investment Promotion, Loan Facilitation and Training;

WHEREAS, the Local Government Unit of Manukan agrees to the roles and responsibilities stipulated in the agreement;

NOW THEREFORE, premises considered, and on motion of Hon. Felicito B. Café duly seconded by majority of the members present, It was


RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the Municipal Mayor to enter into and sign the Memorandum of Agreement with the Department of Trade and Industry (DTI)- Zamboanga del Norte Provincial Office, Region IX relative to the Establishment and Operation of Negosyo Center in the Municipality of Manukan, Zamboanga del Norte.




