A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT WITH THE PROVINCIAL GOVERNMENT OF ZAMBOANGA DEL NORTE RELATIVE TO THE RICE FOR ALL **PROGRAM**

WHEREAS, the Department of Agriculture (DA) has established the "Rice for All (RFA) Program" through Department Circular No. 10, series of 2025, to provide affordable, high-quality Filipino households;

WHEREAS, the Local Government Unit of Manukan has expressed its desire to participate in the said program to ensure food security and provide economic relief to its constituents:

WHEREAS, the Rice for All Program allows for the sale of well-milled rice at a subsidized price, with the subsidy to be shared by the DA-FTI and the participating Local Government Units (LGUs);

WHEREAS, the Provincial Government of Zamboanga del Norte, in its capacity as the head of the local government, has committed to collaborating with the Local Government Unit of Manukan to facilitate the implementation of the program and share in the subsidy cost;
