**A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO AND
SIGN THE MEMORANDUM OF AGREEMENT WITH THE PROVINCIAL
GOVERNMENT OF ZAMBOANGA DEL NORTE RELATIVE TO THE GRANT OF
FINANCIAL ASSISTANCE TO BE DISTRIBUTED AMONG THE BATCH OF
BENEFICIARY BARANGAYS**

WHEREAS, Section 20 of RA 7160 grants LGUs the power to enter into contracts and to acquire and convey real or personal property, while Section 22 authorizes the LGUs to exercise powers necessary for efficient and effective governance and the promotion of the general welfare;

WHEREAS, the Provincial Government of Zamboanga del Norte, has deemed it necessary and proper to provide financial assistance to component municipalities to help them in the implementation of their local development projects;

WHEREAS, the Local Government Unit of Manukan, recognized the importance of collaboration and the needs of the constituents of beneficiary barangays, has approved the grant of financial assistance as a form of inter-LGU cooperation;

WHEREAS, the Memorandum of Agreement will formalize the commitment of the Provincial Government of Zamboanga del Norte to grant a one-time financial assistance of Ten Million Pesos (P 10,000,000.00) to be distributed equally among the "batch of beneficiary barangays" within the Municipality of Manukan which will be used for the procurement of various projects such as, but not limited to Multi-Purpose Vehicle, and/or electrification projects, and/or the establishment of water systems, and/or

concreting of roads, and/or provision of utilities for community development, as the case may be;

WHEREAS, the Local Government Unit of Manukan agrees to the obligations stipulated in the agreement;

NOW THEREFORE, premises considered, and on motion of Hon. Robby Earl B. Villarín duly seconded by majority of the members present, It was

RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the Municipal Mayor to enter into and sign the Memorandum of Agreement with the Provincial Government of Zamboanga del Norte relative to the Grant of Financial Assistance to be Distributed among the Batch of Beneficiary Barangays.

RESOLVED FURTHER, that copies of this resolution be forwarded to HON. ENRIQUITA U. WINTERS-Municipal Mayor, Municipality of Manukan and to HON. DAREL DEXTER T. UY- Provincial Governor, Provincial Capitol, Estaka, Dipolog City for information and reference.
