A RESOLUTION DECLARING IN ORDER ORDINANCE NO. 01, SERIES OF 2023 OF BARANGAY EAST POBLACION AND ORDINANCE NO. 4 OF BARANGAY GUPOT, MANUKAN, ZAMBOANGA DEL NORTE AS IT IS WITHIN THE POWER OF THE SANGGUNIANG BARANGAY TO ENACT PROVIDED UNDER RA 7160

WHEREAS, submitted before this body for review and proper action was Ordinance No. 01, series of 2023 of Barangay East Poblacion, this municipality, entitled: AN ORDINANCE AUTHORIZING THE MUNICIPALITY OF MANUKAN TO ISSUE A BARANGAY CLEARANCE AND COLLECT CORRESPONDING BARANGAY CLEARANCE FEE IN THE APPLICATION FOR ANY BUSINESS-RELATED TRANSACTIONS SUBJECT TO THE REMITTANCE OF THE AFORESAID FEES TO THE BARANGAY AND THE CONDITIONS HEREUNDER and Ordinance No. 4, series of 2023 of Barangay Gupot, this municipality, entitled: AN ORDINANCE AUTHORIZING THE MUNICIPALITY OF MANUKAN TO ISSUE BARANGAY CLEARANCE AND THE MUNICIPAL TREASURER'S OFFICE TO COLLECT CORRESPONDING BARANGAY CLEARANCE FEE IN THE APPLICATION FOR ANY BUSINESS RELATED TRANSACTIONS SUBJECT FOR REMITTANCE OF THE AFORESAID FEES TO THE LOCAL GOVERNMENT UNIT OF BARANGAY GUPOT, MANUKAN, ZAMBOANGA DEL NORTE SUBJECT TO THE CONDITIONS HEREUNDER;

WHEREAS, the authorization of the barangay to collect barangay clearance fees in favor of the barangay is pursuant to Memorandum Circular No. 2019-177 dated October 17, 2019 known as the Guidelines in the Integration of the Issuance of Barangay Clearance in the Permitting Process of the Municipalities;

RESOLVED, AS IT IS HEREBY RESOLVED, to declare in order Ordinance No. 01, series of 2023 of Barangay East Poblacion and Ordinance No. 4, series of 2023 of Barangay Gupot, Manukan, Zamboanga del Norte as it is within the power of the Sangguniang Barangay to enact provided under RA 7160.
